This partnership would be on a sliding scale. The Chamber only makes money off of Vendor Spots which we turn around and use for Advertising/Facility use fees. BLHS DECA would make a portion of income based on the % of Vendor spots sold. 70% of Vendor spots sold would result in 10% donation to DECA, 100% of Vendor Spots sold would result in 20% donation to DECA.
